Architectural Practice Examination

The Architectural Practice Examination (APE) is conducted in Western Australia by the Architects Board of WA (Board). It is conducted twice a year in April/June and September/November and is the final qualification required for registration in all States and Territories of Australia.

The APE is conducted in three parts:

Part 1: Eligibility – Examination of Logbook and Statement of Practical Experience;

Part 2: National Examination Paper; and

Part 3: Examination by Interview.

Please refer to the 2024 Architectural Practice Examination Candidate Handbook on the AACA website (www.aaca.org.au) for the full details and procedure regarding each Part of the APE.

Enrolment for APE

Enrolment dates for the APE are published on the Board's website under the "Graduates" tab in the APE section. Please note that enrolment closes at 4pm, and no extensions will be granted.

Preparing your Application for APE Parts 1 & 2 in WA

If applying in WA, candidates should provide their application for Parts 1 & 2 of the APE to the Board by email to info@architectsboard.org.au

Candidates must include the following documents in their application:

- A Logbook Submission Checklist (on page 2 of this Information Sheet);
- An APE Parts 1 & 2 Application Form 12 (can be found under the "Forms" section on the home page of the Board's website):
- A Statutory Declaration attesting to the accuracy of all documentation submitted. It needs to be signed, and witnessed, by an authorised person (e.g. Justice of the Peace, Pharmacist, Medical Doctor, Architect etc...). A pro forma of the Statutory

Declaration is included on page 3 of this Information Sheet;

- 4. A certified copy of one of the following:
 - Architectural degree certificate (a full academic transcript is acceptable if it shows completion of the course); or
 - Board letter stating attainment of equivalence of qualifications; or
 - Board letter stating attainment of an acceptable standard of practice;
- 5. A PDF of Completed AACA Logbook; and
- 6. A Statement of Practical Experience, including:
 - A one-page summary CV;
 - Project Detail pages;
 - APE Performance Criteria Report;
 - · Verification Signature; and
 - References (if required).
